AMENDED ORDER REGARDING
BRIEFING SCHEDULE

7 On March 21, 2013, the State Environment Commission ("SEC") issued its order
8 establishing a briefing schedule based on a hearing date of May 14, 2013. On April 5, 2013,
9 Appellant Paul Rupp requested that the hearing date be rescheduled and the due dates for
10 the briefs be extended. After consultation with the parties, a new hearing date of July 12,
11 2013 was selected. Therefore, the due dates set forth in the March 21, 2013 Order are
12 vacated and the Order Regarding Briefing Schedule is amended as follows:

13 It is hereby ORDERED that Appellants Paul and Ana C. Rupp and Dehnert Queen shall
14 file a brief with the SEC on or before May 17, 2013. The brief should contain a detailed
15 statement of the issue(s) to be raised during the hearing. It is also ORDERED that Intervener
16 Rockwood Lithium, Inc. and the Nevada Division of Environmental Protection (NDEP) shall
17 each file a responsive brief on or before June 21, 2013. Appellant's reply brief in response to
18 Rockwood Lithium's and NDEP's briefs is due on or before July 5, 2013. It is further
19 ORDERED that on or before July 8, 2013, each party shall exchange with each other party
20 notice of the identity of each person who will offer direct oral testimony at the hearing and
21 each party shall exchange copies of each exhibit the party intends to offer as evidence at the
22 hearing. The parties are encouraged to submit exhibits jointly where possible to avoid
23 duplicate exhibits. In addition, the appeal hearing date of May 14, 2013 is vacated and the
24 appeal hearing is scheduled for July 12, 2013 beginning at 10:30 a.m.
