ORDER REGARDING
BRIEFING SCHEDULE

8 On September 29, 2014, Coyote Springs Investment, LLC ("Coyote Springs") filed an
9 appeal of Permit SW1722REV00 issued on September 19, 2014, by the Nevada Division of
10 Environmental Protection to operator Bedroc Limited, LLC ("Bedroc"), for a Class I Permit to
11 Operate a Municipal Waste Area-Fill Disposal Site.

12 Pursuant to NAC 445B.8925, it is hereby ORDERED that Coyote Springs shall file its
13 opening brief with the State Environmental Commission ("SEC") on or before January 20,
14 2015. The brief should contain a detailed statement of the issue(s) to be raised during the
15 hearing. It is also ORDERED that Bedroc and the Nevada Department of Environmental
16 Protection shall each file a response brief on or before February 3, 2015. It is also ORDERED
17 that Coyote Springs may file a reply brief on or before February 10, 2015. It is further ordered
18 that on or before February 12, 2015, each party shall exchange with all other parties, notice of
19 the identity of each person who will offer direct oral testimony at the hearing and that each
20 party shall exchange copies of each exhibit the party intends to offer as evidence at the
21 hearing. The parties are encouraged to submit exhibits jointly where possible to avoid
22 duplicate exhibits. In addition, the appeal hearing in this matter is scheduled for February 17,
23 2015.


