

ORDER DISMISSING APPEAL

7 This matter is again before the State Environmental Commission ("Commission") after
8 the Nevada Supreme Court issued an order on November 13, 2008, dismissing Beverly Hills
9 Dairy's appeal of a district court order which remanded the matter to the Commission. On
10 June 28, 2010, counsel for the Nevada Division of Environmental Protection ("NDEP")
11 informed the Commission that on June 15, 2010, it had terminated Permit NEV2006504 at the
12 request of Rockview Farms, Inc. and it requested that this pending appeal be dismissed as
13 moot. On July 20, 2010, the Commission notified counsel for NDEP, Bill Barrackman, and
14 Beverly Hills Dairy that it would dismiss the appeal as moot unless written objections were
15 filed on or before August 13, 2010. Having received no written objections,

16 IT IS THEREFORE ORDERED that NDEP's request is GRANTED and the above-
17 referenced appeal is dismissed as moot.


