



Hearing Agenda - SEC Appeal Hearing
Fencemaker Project
Water Pollution Control Discharge Permit NEV2009104

A three-member panel of the State Environmental Commission (SEC) has scheduled an appeal hearing on the above referenced permit. The hearing will be held on November 14, 2016 beginning at 10:00 a.m. in Carson City, Nevada at the Bryan Building, 901 S. Stewart St., 2nd floor, Tahoe Conference Room.

The following items may be taken out of order and/or items may be combined for consideration. Items may also be removed from the agenda or the SEC may delay discussion relating to an item on the agenda at any time. Prior to the commencement and conclusion of a contested case or a quasi-judicial proceeding that may affect the due process rights of an individual, the SEC may refuse to consider public comment. See NRS 233B.126.

1. Public Comment (**Discussion**)

Members of the public will be invited to speak before the SEC; however, no action may be taken on a matter during public comment until the matter itself has been included on an agenda as an item for possible action. Public comment may be limited to five minutes per person at the discretion of the chairperson.

3. Public Comment (**Discussion**)

Public comment may be limited to five minutes per person at the discretion of the chairperson and is subject to the requirements noted in agenda item 1 above.
