7 On March 15, 2010, Philip Jacka, Robert E. Dolan and Massey Mayo each filed an
8 appeal of Permit No. AP4953-2525 issued on March 5, 2010 by the Nevada Division of
9 Environmental Protection to Jungo Land & Investments, Inc. for an operating permit to
10 construct a Class I facility.

11 On March 23, 2010, Jungo Land & Investments, Inc. filed a Petition for Leave to
12 Intervene with the State Environmental Commission ("SEC"). As indicated in the Petition for
13 Leave to Intervene, Jungo Land & Investments, Inc. has a direct and substantial interest in the
14 appeal because it is the named permittee of Permit No. AP4953-2525 being appealed by the
15 parties named above. Jungo Land & Investments, Inc. will therefore be directly affected by a
16 decision of the SEC.

17 Based upon the foregoing, it is hereby ordered that the Petition for Leave to Intervene
18 filed by Jungo Land & Investments, Inc. is GRANTED pursuant to NAC 445B.8915.
