RE: Notice of Alleged Air Quality Violation and Order Nos. 2481, 2482 and 2483 Class II Air Quality Operating Permit for Temporary Sources AP1442-3316.03 (FIN A1619)

Dear Ms. Hudson:

On March 26, 2014, the Nevada Division of Environmental Protection (NDEP) held an enforcement conference with Jetcrete North America (Jetcrete) to discuss supporting information regarding the draft Notice of Alleged Violation and Order (NOAV) Nos. 2481, 2482 and 2483. As a result of that meeting, NDEP formally issued NOAV Nos. 2481 and 2482. NOAV No. 2483 was issued as a warning. See attached.

NDEP sent NOAV Nos. 2481, 2482 and 2483 via certified mail on April 4, 2014, notifying Jetcrete of its appeal rights pursuant to NRS 445B.340 and NRS 445B.360. Jetcrete did not appeal the NOAVs. Therefore, the State Environmental Commission (SEC) will determine the appropriate penalty for the violations contained in the above referenced NOAVs on **Wednesday, October 8, 2014 at 9:00 a.m.** in the Bryan Building in Carson City, Nevada (901 S. Stewart Street, 2nd Floor Tahoe Room).


Pursuant to NRS 445B.640(1), the SEC may approve an administrative penalty of not more than \$10,000 per day per violation. During the October 8 meeting, NDEP will provide the SEC with a brief overview of the NOAVs and its recommendation for an administrative penalty of \$9,600.00. This recommended penalty was calculated using a penalty matrix previously approved by the SEC.

Although your presence is not required at this meeting, you or a representative may wish to attend to speak on behalf of Jetcrete.

The SEC may, without further notice, take administrative action against Jetcrete if the SEC determines that such administrative action is warranted after it considers NOAV Nos. 2481, 2482 and 2483.
