Dear Ms. Corp:

Enclosed is a permanent regulation referenced above that was adopted by the State Environmental Commission (SEC) on October 8, 2014. Also enclosed is the informational statement required by NRS 233B.066, the small business impact statement, the notice of adoption of the regulation and lastly, the change that the regulation was adopted with.

The Nevada Revised Statutes (NRS) 445A.270 establishes the authority of the State Environmental Commission to adopt regulations as necessary to carry out the provisions of the account for the revolving fund and the account for the set-aside program. The proposed regulation changes provide for general updates, language clarification, streamlining, organization, and cleanup. Proposed changes include added factors to the priority list ranking (NAC 445A.67569). Some of the additional factors will encourage sustainability by awarding additional points for capacity development. Other additions will better outline project types.
