Regulation Amendment Workshop - August 27, 2015

The Nevada Division of Environmental Protection (NDEP) Bureau of Safe Drinking Water (BSDW) will hold a Public Workshop on Thursday, August 27, 2015 at 2:00 pm in Carson City with videoconference to Las Vegas. Flamingo Rd., Suite 230. The purpose of the meeting is to receive comments from all interested persons regarding the information listed on this agenda.

The following items may be combined for consideration. Items may also be removed from the agenda or the BSDW may delay discussion relating to an item on the agenda at any time.

The proposed amendment addresses NAC 278.340 and associated regulations pertaining to Subdivision of Land. The BSDW will present the proposed regulation amendments, describe the regulatory amendment processes, and provide additional background on the purpose and need for the proposed amendment.
