The Nevada Division of Environmental Protection (NDEP) is proposing regulations that will update the existing Alternative Fuels in Fleets Program by changing the types of fuels that can be used by fleets, changing the definitions of alternative fuel vehicles and clean vehicles, and changing the program's reporting requirements. Permanent Regulation P2016-06: The NDEP is proposing to update the definitions of alternative fuel, alternative fuel vehicles, and clean vehicles, to change the fleet acquisition or replacement requirements, to change fleet reporting requirements, and other related revisions. The amendments will update the NAC to further the program's mission. With the elimination of reformulated gasoline as an alternative fuel, NDEP is updating the program to reflect upcoming changes to national fuel standards.
