Enclosed for "drafting" by the LCB Legal Division is a proposed permanent regulation that would amend NAC 445B.138. The Nevada Division of Environmental Protection is proposing to amend four sections in the permitting provisions of NAC 445B. The amendments are in response to U.S. EPA comments on the approvability of the agency's air pollution control permitting provisions into the applicable State Implementation Plan. The amendments align state regulations with the federal Clean Air Act and U.S. EPA rule requirements.
