Please note that we originally sent this regulation to you on September 26, 2007. The regulation was, however, pulled for the SEC's December 04, 2007 agenda. We have subsequently revised the regulation to reflect response to stakeholder comments (e.g., insertion of the California Climate Action Registry) and certain corrections to the LCB draft of the initial regulation.
