Enclosed for "drafting" by the LCB Legal Division is a proposed permanent regulation that will amend regulations governing hazardous waste management found in Chapter 444 of the Nevada Administrative Code (NAC). The proposed amendments will update Nevada's adoption of federal regulations by reference.

The regulation will modify NAC 444.8427, 84275, 850, 8688, 8871, 8881, 8926, 8931, 8941, 9006, 9011 and 9452 to refer to the federal regulations as they existed on July 1, 2006, and modify NAC 444.8632 to adopt 40 CFR Parts 2, Subpart A, 124, Subparts A and B, Parts 260 to 270, inclusive, and Part 279 as those parts existed on July 1, 2006. These proposed amendments will allow the State to implement the RCRA hazardous Waste program in lieu of the federal government.
