This regulation adopts the federal National Emission Standards for Hazardous Air Pollutants rules for area sources that have recently been issued by the US EPA. This proposed permanent regulation was adopted by the SEC as a temporary regulation (T008-11) on June 16, 2011. The permanent implements emission standards through a new, streamlined Class IV Operating Permit program.
