Notice of Hearing for the Amendment of Regulations of the Nevada Division of Environmental Protection

The Nevada Division of Environmental Protection (NDEP) is seeking approval for its Proposed Subdivision Regulations. The proposed regulations are to complete the transfer of authorities covered by Senate Bill (SB) 395. SB395, passed in the 2005 Legislative session transferred statutory and regulatory authorities for Subdivision Review Programs (Nevada Revised Statute (NRS) and Nevada Administrative Code (NAC) 278) from the Nevada Division of Health to the Nevada Division of Environmental Protection (NDEP). The proposed regulations revise the text references of "Health Division" to "Division of Environmental Protection." The above referenced regulations were originally adopted by the State Board of Health in 1982 in order to implement the statutory responsibilities of NRS 278. These responsibilities were transferred to

NDEP by SB 395. These responsibilities include the review of tentative maps and approval of final subdivision maps. Final map approval, as amended by SB 395, is found in NRS 278.377.

The proposed regulations will not have an economic impact, either immediate or long term, on the regulated industry and small businesses. The proposed regulation changes have beneficial effects for the regulated industry through a streamlined process within the NDEP. There will be no additional costs to the agency for enforcement of these amendments. The amended regulations do not include any new provisions, which are more stringent than federal regulations. Furthermore, they do not overlap, duplicate or are in conflict with any regulations of other state or government agencies.

Persons wishing to comment or object to any of the Administrator's proposed regulation changes may do so by attending a workshop and making public comment, or submitting their comment, in writing, by November 5, 2008 either in person or by mail to:

All comments or objections received within the thirty (30) day comment period will be considered in the formulation of final determinations regarding the proposed regulation changes. All comments must be received by November 5, 2008. If the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for and against its adoption, and incorporate therein its reason for overruling the consideration urged against its adoption.
