RE: Filing of Permanent Regulation R052-12: DMV Smog Check Program

Dear Ms. Corp:

Enclosed is a permanent regulation referenced above that was adopted by the State Environmental Commission (SEC) on February 13, 2013. Also enclosed is the filing statement required by NRS 233B.066 and the SEC form for filing administrative regulations with the Secretary of State.

The regulations create a new, voluntary program which will allow fleets to comply with motor vehicle emissions testing requirements by means of engaging the services of an authorized vendor of an electronic data management and monitoring system. Under this program, vendors will attach electronic devices to fleet vehicles that will monitor the vehicles' emission control systems and transmit emissions compliance data directly to the DMV in an electronic format.
