NOTICE OF PUBLIC WORKSHOP

NOTICE IS HEREBY GIVEN that the Nevada Division of Environmental Protection will hold a public workshop to provide an opportunity for comment on proposed revisions to the Nevada Administrative Code (NAC) governing the Clean Water State Revolving Fund for construction of wastewater treatment and pollution control projects.

Revisions to the regulation are intended to make program elements of the Clean Water and Drinking Water State Revolving Fund more consistent. The proposed revisions also remove the requirement that project design be completed prior to project funding. The removal of this requirement will allow communities, which cannot afford up front engineering cost, to utilize state revolving funds for such activities. The proposed regulation also removes confusing language for calculating fixed amounts for planning and design costs.

This regulation will not have an immediate or long-term adverse economic impact on the public or the business community. There will be no additional costs to the agency for enforcement of the proposed regulation and the regulation does not overlap, duplicate or conflict with any regulations of other government agencies. The regulation does not address fees.
