RE: Filing of Permanent Regulation R123-11: A Regulation Relating to Solid Waste

Dear Ms. Corp:

Enclosed is a permanent regulation referenced above that was adopted by the State Environmental Commission (SEC) on February 15, 2012. Also enclosed is the filing statement required by NRS 233B.066 and the SEC form for filing administrative regulations with the Secretary of State.

This proposed permanent regulation amends NAC 444.748. The regulation simply clarifies the jurisdictional responsibilities associated with appeals concerning the management and disposition of solid waste by Nevada's three Solid Waste Management Authorities. The regulation makes clear that only those appeals involving the management of solid waste, which are under the direct regulatory control of the Nevada Division of Environmental Protection (NDEP), must conform to the procedural rules of the State Environmental Commission (SEC) as codified under NAC 445B.875.
