Enclosed is permanent regulation that was adopted by the Nevada State Environmental Commission on October 6, 2009. The regulation was subsequently approved on October 27, 2009 by the Nevada Legislature's Legislative Commission.

The regulation is titled R194-08: Public Water Systems: **Permanent Regulation R194-08: Public Water Systems**: With this regulation, the Nevada Division of Environmental Protection, Bureau of Safe Drinking Water (NDEP/BSDW) is updating its Federal adoption by reference date for regulations that have been promulgated by the U.S. Environmental Protection Agency (US EPA) from July 1, 2005 to July 1, 2006. During this period, the US EPA codified the Long Term 2 Enhanced Surface Water Treatment Rule and the Stage 2 Disinfectants and Disinfection Byproducts Rule which the NDEP is now adopting.

We are filing the regulation with the Nevada State Library and Archives pursuant to NRS 233B.070.
