
On December 5, 2012, the State Environmental Commission (SEC) granted McDermitt Water System (McDermitt) a final Arsenic Rule exemption extension which will expire on January 23, 2015. During the same meeting, the SEC requested that all Water Systems granted this extension provide the SEC a status briefing in one year's time if there is concern regarding compliance with the Rule by the extended deadline.

As a result of the Nevada Division of Environmental Protection's (NDEP) concerns regarding McDermitt's compliance by the extended deadline, the SEC requests your presence during its December 2013 regulatory meeting. The SEC will expect to be briefed on McDermitt's progress towards achieving compliance with the Arsenic Rule by January 23, 2015.

The SEC meeting will be held on Wednesday, December 4, 2013, at 10:00 am, located in the Bryan Building at 901 South Stewart Street, Carson City, in the Tahoe Room on the second floor.
