On December 5, 2012, the State Environmental Commission (SEC) granted Silver Knolls Mutual Water Company Public Water System (Silver Knolls) a final Arsenic Rule exemption extension which will expire on January 23, 2015. During the same meeting, the SEC requested that all Water Systems granted this extension provide the SEC a status briefing in one year's time if there is concern regarding compliance with the Rule by the extended deadline.
