Class II Air Quality Operating Permit AP1499-0504.02 (FIN A0739)

Dear Mr. Wilson:

On July 30, 2012, the Nevada Division of Environmental Protection, Bureau of Air Pollution Control (NDEP-BAPC) held an enforcement conference with Western States Gypsum (WSG) to discuss the information regarding Notice of Alleged Violation and Order (NOAV) Nos. 2416, 2417, 2418 and 2419. Based on the information presented during the enforcement conference the NDEP-BAPC has made the determination to formally issue NOAV Nos. 2416, 2417, 2418 and 2419 should not be issued. NOAV Nos. 2416, 2417, 2418 and 2419 represent air quality violations under **NAC 445B.275 Violations: Acts constituting; notice** (see below).

The attached NOAV Nos. 2416, 2417, 2418 and 2419 allege that WSG is in violation of **Nevada Administrative Code (NAC) 445B.275 Violations: Acts constituting; notice**. NAC 445B.275 states, in part, that: "1. Failure to comply with any requirement of NAC 445B.001 to 445B.3791, inclusive, any applicable requirement or any condition of an operating permit constitutes a violation. As required by Nevada Revised Statutes NRS 445B.450, the Director shall issue a written notice of an alleged violation to any owner or operator for any violation, including, but not limited to:

- (a) Failure to apply for and obtain an operating permit.
- (c) Failure to construct or operate a stationary source in accordance with any condition of an operating permit.
- (e) Failure to comply with any requirement for recordkeeping, monitoring, reporting or compliance certification contained in an operating permit.

NOAV Nos. 2416, 2417, and 2419 constitute major violations under **NAC 445B.281 Violations: Classification; administrative fines**. NOAV No. 2418 constitutes a minor violation under **NAC 445B.281 Violations: Classification; administrative fines**. NOAV Nos. 2416, 2417, 2418 and 2419 are the second NOAV's issued to WSG in the past 60 months. As discussed in the enforcement conference, NOAV Nos. 2417, 2418 and 2419 will be issued as warnings.



**It is alleged that the following act or practice constitutes the violation:**

Constructing and operating regulated emission units without applying for and obtaining an operating permit.

**Evidence:**

On June 1, 2012, the Nevada Division of Environmental Protection, Bureau of Air Pollution Control (NDEP-BAPC) conducted an inspection of the Western States Gypsum (WSG) operation located in Lyon County, Nevada. WSG operates under Class II Air Quality Operating Permit AP1499-0504.02, issued on August 13, 2007.

Prior to the June 1, 2012 inspection, on March 28, 2012 the NDEP-BAPC went to WSG to meet with Mr. Art Wilson, owner/operator of WSG, to discuss how to add equipment to WSG's current air quality operating permit. NDEP-BAPC explained to Art Wilson that the current air quality operating permit needed to be modified before any new equipment could be constructed. NDEP-BAPC then explained the process of a modifying the permit Mr. Wilson. Mr. Wilson said he understood and then questioned the cost of modifying the permit. The NDEP-BAPC had explained to Mr. Wilson that the cost to modify the permit would be \$2,000.

During the June 1, 2012 inspection, the NDEP-BAPC discovered that WSG had constructed regulated emission units without acquiring a required air quality operating permit. There were two pieces of equipment that were constructed that were not on the current Class II Air Quality Operating Permit. The equipment includes a hopper and a conveyor belt. The unpermitted equipment was documented with pictures.
