

**PROPOSED TEMPORARY REGULATION OF THE
STATE ENVIRONMENTAL COMMISSION**

Petition 2001-06

Explanation - Matter in *italics* is new; matter in brackets [~~omitted material~~] is material to be omitted.

1 **Section 1.** Chapter 459 of NAC is hereby amended by adding thereto the provisions
2 set forth as sections 2 to 27, inclusive, of this regulation.

3 **Sec. 2.** *“Explosive” means gunpowders, powders used for blasting, all forms*
4 *of high explosives, blasting materials, fuses other than electric circuit breakers,*
5 *detonators and other detonating agents, smokeless powders, other explosive or*
6 *incendiary devices and any chemical compound, mechanical mixture or device*
7 *that contains any oxidizing and combustible units, or other ingredients, in such*
8 *proportions, quantities or packing that ignition by fire , friction, concussion,*
9 *percussion, or detonation of the compound, mixture or device or any part thereof*
10 *may cause an explosion. The term includes any mixture of ammonium nitrate*
11 *and fuel oil. The term does not include any ammunition, powder, percussion*
12 *caps, fuses, quills, matches, primers or explosive materials specified in 18 U.S.C.*
13 *§ 845(a)(4)-(6).*

14 **Sec. 3.** *“Explosives manufacturing operation” means a process, which*
15 *involves the manufacture of explosives for sale, notwithstanding the presence of*
16 *tier A or tier B substances. This term also includes explosive storage sites which*
17 *are incidental to the manufacture of explosives for sale.*

18

1 **Sec. 4.** *“First responding fire station” means the local fire department*
2 *station that typically responds to emergency calls from the facility, and is*
3 *usually the station that is first on scene during an emergency.*

4 **Sec. 5.** *“Hazardous materials response station” means the local fire*
5 *department station that is equipped and trained to provide hazardous materials*
6 *response capability to the facility in accordance with 29CFR1910.120(q).*

7 **Sec. 6.** *“Local Building Official” means the authority that is charged with*
8 *the administration and enforcement of local building codes.*

9 **Sec. 7.** *“Local Fire Department Authority” means the authority that is*
10 *charged with the administration and enforcement of local fire codes.*

11 **Sec. 8.** *“New explosives manufacturing operation” means an explosives*
12 *manufacturing operation that has been, or will be installed at the facility and*
13 *will be operated for the first time at this location.*

14 **Sec. 9.** *“New process” means a process that has been, or will be installed at*
15 *the facility and will be operated for the first time at this location.*

16 **Sec. 10.** *“Trade Secret” means information that satisfies the criteria*
17 *established by subsection 4 of NRS 459.3846.*

18 **Sec. 11.** *Before the owner or operator of a facility commences the*
19 *construction of a new process or new explosives manufacturing operation that*
20 *will become subject to the provisions of tier A pursuant to NAC 459.95323, or*
21 *tier B, program level 2 or 3, pursuant to NAC 459.95325 and 459.95327, the*
22 *owner or operator shall obtain a permit to construct from the division, pursuant*
23 *to sections 13 through 24, inclusive, of this regulation.*

24 **Sec. 12.** *Before the owner or operator of a facility:*

25 **1.** *Commences the operation of a new process or new explosives*
26 *manufacturing facility that will become subject to the provisions of Tier A*
27 *pursuant to NAC 459.95323, or tier B, program level 2 or 3, pursuant to NAC*
28 *459.95325 and 459.95327; or*

1 2. *Brings tier A or B substances or explosives on site,*
2 *The owner or operator shall obtain a permit to commence operation from the*
3 *division, pursuant to section 25 of this regulation.*

4 **Sec. 13.** *Prior to applying for a permit to construct, the owner or operator*
5 *shall meet with the division to:*

6 1. *Discuss the project scope and the applicable design and construction codes*
7 *and standards;*

8 2. *Discuss the document submission requirements; and*

9 3. *Discuss project schedule.*

10 **Sec. 14.** 1. *The owner or operator of the new process or new explosives*
11 *manufacturing operation that will become subject to the provisions of Tier A*
12 *pursuant to NAC 459.95323, or tier B, program level 2 or 3, pursuant to NAC*
13 *459.95325 and 459.95327, shall provide three complete sets of the permit to*
14 *construct application to the division. The application shall be made on forms*
15 *prescribed by the division and shall include:*

16 (a) *A registration containing:*

17 (1) *Information required pursuant to NAC 459.95454, 459.95456,*
18 *459.95464 and 459.95452;*

19 (2) *The name, address and telephone number of the company submitting*
20 *the plans;*

21 (3) *A project overview, describing:*

22 (I) *The process;*

23 (II) *The hours of operation;*

24 (III) *The number of personnel anticipated per shift, including operations,*
25 *maintenance, office staff, contract personnel and any other personnel;*

26 (IV) *The modes of transport for incoming and outgoing raw materials and*
27 *products and transport routes;*

28

- 1 (V) *The frequency and hours of transport of incoming and outgoing raw*
2 *materials and products;*
- 3 (VI) *The scope of the construction project; and*
- 4 (VII) *The project schedule;*
- 5 (4) *Construction inspector information required pursuant to section 21 of*
6 *this regulation; and*
- 7 (b) *The coordinated emergency response plan document developed pursuant*
8 *to NAC 459.9544 and 459.95442;*
- 9 (c) *Process safety information and process hazard analysis documents*
10 *required pursuant to section 16 of this regulation;*
- 11 (d) *Drawings, specifications, and calculations required pursuant to*
12 *sections 17, 18 and 19 of this regulation; and*
- 13 (e) *A copy of the conditional use permit issued pursuant to NRS 278.147.*
- 14 2. *The documents, drawings and calculations submitted pursuant to*
15 *sections 17, 18 and 19 of this regulation shall be stamped or sealed by the*
16 *engineer that has responsible charge of the work pursuant to NAC 625.610 and*
17 *NAC 625.611. A table of contents or cover sheet shall be submitted with*
18 *specifications that complies with the requirements of subsection 3 of*
19 *NAC 625.611.*
- 20 3. *The owner or operator may request that select information submitted*
21 *pursuant to this section be held as trade secret. Any information submitted*
22 *pursuant to this section that the division determines to be trade secret must:*
- 23 (a) *Not be disclosed by the division to the public;*
- 24 (b) *Not be reproduced by the division;*
- 25 (c) *Not be disclosed to a consultant to the division unless the consultant has*
26 *executed proper agreements to protect such information; and*
- 27 (d) *Be returned in its entirety to the submitting owner or operator upon*
28 *completion of the permitting process.*

1 **Sec. 15. 1.** *Upon receipt of a permit to construct application, the division*
2 *must review the application to determine if all information required under*
3 *section 14 of this regulation has been submitted. The division must provide an*
4 *initial completeness determination pursuant to either subsection 2 or 3 of this*
5 *section, within 30 days.*

6 **2.** *If the division determines that all information required pursuant to*
7 *section 14 of this regulation has been submitted, they must notify the owner or*
8 *operator accordingly.*

9 **3.** *If the division determines that information required pursuant to section 14*
10 *of this regulation is incomplete, they must notify the owner or operator of the*
11 *deficiencies. The division may, at its discretion, return all submitted*
12 *information.*

13 **4.** *The division may elect to delay the review of information submitted*
14 *pursuant to section 14 of this regulation, until the application is determined to*
15 *be complete.*

16 **Sec. 16.** *The process safety information and process hazard analysis required*
17 *to be submitted pursuant to section 14 of this regulation shall indicate the*
18 *current revision number and date and shall consist of:*

19 **1.** *Information pertaining to the hazards of any tier A or B substance or*
20 *explosive as required pursuant to paragraph (a) of subsection 2 of NAC*
21 *459.95412;*

22 **2.** *A description of the process chemistry as required pursuant to*
23 *subparagraph (2) of paragraph (b) of subsection 2 of NAC 459.95412. The*
24 *process chemistry must note all potential side reactions, whether or not the*
25 *reactions create hazardous consequences;*

26 **3.** *A description of the safe upper and lower limits and the consequences of*
27 *deviating from those limits as required pursuant to subparagraphs (4) and (5) of*
28 *paragraph (b) of subsection 2 of NAC 459.95412;*

1 4. *If not readily apparent from the piping and instrument diagrams, control*
2 *logic documentation to enable understanding of process controllers, switches*
3 *and interlocks. All such documentation shall be as concise as possible to enable*
4 *efficient utilization by the division;*

5 5. *A list of equipment and instruments, traceable to the piping and*
6 *instrument diagram, and select design and code information as requested by the*
7 *division;*

8 6. *A material and energy balance as required pursuant to subparagraph (7) of*
9 *paragraph (c) of subsection 2 of NAC 459.95412;*

10 7. *The safety system description as required pursuant to subparagraph (8) of*
11 *paragraph (c) of subsection 2 of NAC 459.95412; and*

12 8. *The complete process hazard analysis, performed pursuant to*
13 *NAC 459.95414.*

14 **Sec. 17.** *Drawings, as defined in this section, shall be submitted pursuant to*
15 *section 14 of this regulation. All drawings shall indicate the current revision*
16 *number and date and be of sufficient quality to be legible after reproduction.*
17 *Where plans are drawn to scale, the scale shall be indicated and a bar scale shall*
18 *be included. The drawings to be submitted shall consist of:*

19 1. *A site plan, drawn to scale, which locates the facility containing the new*
20 *process or new explosives manufacturing operation on a map depicting city or*
21 *county roads. The site plan shall show at a minimum:*

22 (a) *An area encompassing the endpoint of the worst case release scenario*
23 *developed pursuant to NAC 459.95366, and the first responding fire station and*
24 *hazardous materials response station that are identified pursuant to paragraph e*
25 *of this subsection;*

26 (b) *A graphical delineation of the endpoints of each worst case and alternate*
27 *case release scenario developed pursuant to NAC 459.95366 and 459.95368.*

28 (c) *Major roads and transportation corridors;*

- 1 (d) *Routes for incoming and outgoing raw materials and products;*
2 (e) *The location of the first responding fire station, and the hazardous*
3 *materials response station; and*
4 (f) *The location of schools, hospitals, and other public receptors within the*
5 *plan area defined in paragraph (a) of this subsection.*

6 2. *Plot plans of the project area, shown on separate drawings, drawn to scale,*
7 *showing:*

8 (a) *Major equipment locations, tier A substance, tier B substance and*
9 *explosives locations and maximum intended inventories at those locations;*

10 (b) *Safety systems, including without limitation:*

11 (1) *Firewater and other suppression system tankage locations;*

12 (2) *System pump locations and distribution piping routing;*

13 (3) *Hydrant, monitor and other fire suppression equipment locations;*

14 (4) *Toxic and combustible gas and flame detector locations;*

15 (5) *Personal protective equipment locations; and*

16 (6) *Manufacturer, model number and quantities for items identified under*
17 *subparagraphs 1 through 5, inclusive, of this paragraph; and*

18 (c) *Electrical hazardous area locations required pursuant to subparagraph (3)*
19 *of paragraph (c) of subsection 2 of NAC 459.95412. The plot plan and necessary*
20 *elevation and detail drawings shall be provided to distinguish between*
21 *electrically unclassified and electrically classified areas as defined in Article 500*
22 *of N.F.P.A. 70, the National Electric Code, which is adopted by reference*
23 *pursuant to NAC 459.95528. Additionally, the drawing shall denote the*
24 *nationally recognized code or standard utilized to determine the extent of the*
25 *electrically classified area.*

26 3. *Process flow diagrams, shown on one or more drawings as necessary,*
27 *developed pursuant to subparagraph (1) of paragraph (b) of subsection 2 of*

1 *NAC 459.95412. The process flow diagram shall correspond to the material and*
2 *energy balance submitted pursuant to section 16 of this regulation.*

3 *4. Piping and instrument diagrams, shown on one or more drawings as*
4 *necessary, developed pursuant to subparagraph (2) of paragraph (c) of*
5 *subsection 2 of NAC 459.95412. The piping and instrument diagrams shall:*

6 *(a) Be submitted on 11 inch by 17 inch sheets on an easily legible scale;*

7 *(b) Cover the new process as well as any associated utility systems, including*
8 *without limitation, air, water, nitrogen and process drain systems;*

9 *(c) Include all piping, equipment, instruments and controls; and*

10 *(d) Correspond to:*

11 *(1) The process flow diagrams developed pursuant to subsection 3 of this*
12 *section;*

13 *(2) The equipment lists, control logic documentation and the process*
14 *hazard analysis submitted pursuant to section 16 of this regulation; and*

15 *(3) The specifications submitted pursuant to section 18 of this regulation.*

16 *5. Concrete foundation drawings for equipment and structures related to the*
17 *new process or explosives manufacturing operation that are not subject to review*
18 *and approval by the local building official. The drawings shall include:*

19 *(a) Base and subbase preparation, including compaction requirements;*

20 *(b) Forms, reinforcing bar and appurtenance requirements;*

21 *(c) Concrete and grout specifications;*

22 *(d) Testing and inspection requirements; and*

23 *(e) Applicable codes, standards or industry recommended practices governing*
24 *the design and construction.*

25 *6. Structural steel drawings for equipment and piping supports related to the*
26 *new process that are not subject to review and approval by the local building*
27 *official. The drawings shall include;*

28

- 1 (a) *Steel and bolting specifications;*
2 (b) *Welding, testing and inspection requirements; and*
3 (c) *Applicable codes, standards or industry recommended practices governing*
4 *the design and construction.*

5 7. *Any other drawings as requested by the division.*

6 **Sec. 18.** *Specifications, as defined in this section, shall be submitted*
7 *pursuant to section 14 of this regulation. All specifications shall indicate the*
8 *current revision number and date.*

9 1. *The specifications shall define:*

10 (a) *The applicable codes, standards or industry recommended practices to be*
11 *followed for the design, construction and inspection of the new process or a new*
12 *explosives manufacturing operation;*

13 (b) *The design conditions, including maximum allowable working pressures,*
14 *design temperatures and seismic criteria, where applicable;*

15 (c) *The required materials of construction;*

16 (d) *The qualification requirements for installation methods used and for the*
17 *personnel performing the construction and inspection activities; and*

18 (e) *Inspection and testing requirements.*

19 2. *As applicable to the project, specifications shall be provided for:*

20 (a) *Piping, fittings and valves; and*

21 (b) *Other specifications, only as required by the division.*

22 **Sec. 19. 1.** *Calculations, as defined in this section, shall be submitted*
23 *pursuant to section 14 of this regulation. All calculations shall indicate the*
24 *current revision number and date. Calculations shall be provided for:*

25 (a) *Concrete foundations for drawings submitted pursuant to section 17 of*
26 *this regulation. A soils report shall also be submitted to support design*
27 *calculations;*

28

1 ***(b) Structural steel for drawings submitted pursuant to section 17 of this***
2 ***regulation; and***

3 ***(c) Pressure relief devices submitted pursuant to section 16 of this regulation.***

4 ***2. Applicable codes, standards or industry recommended practices governing***
5 ***the design and construction shall be noted on the calculations.***

6 ***3. Computer generated calculations shall include:***

7 ***(a) A complete description of the mathematical model used in the design;***

8 ***(b) Design program identification, input data required, program application***
9 ***limitations and final results.***

10 ***A program description or user's manual may be required to be submitted to the***
11 ***division.***

12 ***4. Supporting information, including vendor data, shall be provided to the***
13 ***division as requested.***

14 **Sec. 20. RESERVED**

15 **Sec. 21. Construction inspector information provided to the division**
16 ***pursuant to section 14 of this regulation shall identify:***

17 ***1. Each inspector to be employed by the owner or operator;***

18 ***2. The scope of the inspection services to be provided by each inspector,***
19 ***including the types of observations and tests; and***

20 ***3. The qualifications of the inspector that enables performance of their***
21 ***duties. Where certification or other credentials are required by code or standard,***
22 ***copies of the appropriate credentials shall be provided.***

23 **Sec. 22. 1. The division shall issue a permit to construct when:**

24 ***(a) The division approves the offsite consequence analysis developed pursuant***
25 ***to NAC 459.95362 through 459.95372, inclusive;***

26 ***(b) The division determines that the construction inspectors selected by the***
27 ***owner or operator:***

28

1 (1) *Will, at a minimum, provide inspection as required by applicable*
2 *specifications, codes, or standards and ensure construction and installation*
3 *pursuant to those specifications, codes or standards; and*

4 (2) *Are qualified by experience, and when required by specifications, codes*
5 *or standards, have appropriate training and certification.*

6 (c) *RESERVED;*

7 (d) *The division determines:*

8 (1) *The emergency response plan developed pursuant to NAC 459.9544 and*
9 *459.95442 is complete;*

10 (2) *Full time emergency response capability is available; and*

11 (3) *Hazardous materials response capability:*

12 (I) *Is available pursuant to the requirements of 29 CFR 1910.120;*

13 (II) *Is available 24 hours per day; and*

14 (III) *Will be provided by an organization that is not a volunteer fire*
15 *department;*

16 (e) *The division determines that the process hazard analysis complies with*
17 *NAC 459.95414;*

18 (f) *The division approves the site plan developed pursuant to subsection 1 of*
19 *section 17 of this regulation. For the division to approve the site plan:*

20 (1) *The worst case release scenario developed pursuant to NAC 459.95366,*
21 *shall be mitigated in a manner acceptable to the division to minimize the impact*
22 *on public receptors located outside the industrial zoning district. At a minimum,*
23 *some level of passive or active mitigation must be employed;*

24 (2) *The alternate case release scenarios developed pursuant to NAC*
25 *459.95368, shall be mitigated in a manner acceptable to the division to prevent*
26 *the endpoint as defined in subsection 1 of NAC 459.95364 from reaching a*
27 *public receptor located outside the industrial zoning district. Active mitigation*
28 *may be considered by the division to satisfy this requirement; and*

1 (3) *The locations of the emergency responders as shown on the site plan*
2 *shall be consistent with the locations noted in the emergency response plan*
3 *developed pursuant to NAC 459.9544 and 459.95442;*

4 (g) *The division approves:*

5 (1) *The plot plan developed pursuant to paragraph a of subsection 2 of*
6 *section 17 of this regulation;*

7 (2) *The electrical hazardous area location plan developed pursuant to*
8 *paragraph c of subsection 2 of section 17 or this regulation, except that the*
9 *division will accept a local building official approval of this drawing;*

10 (3) *The piping and instrument diagrams developed pursuant to subsection*
11 *4 of section 17 of this regulation;*

12 (4) *The concrete foundation drawings developed pursuant to subsection 5*
13 *of section 17 of this regulation;*

14 (5) *The structural steel drawings developed pursuant to subsection 6 of*
15 *section 17 of this regulation;*

16 (6) *The specifications developed pursuant to section 18 of this regulation;*
17 *and*

18 (7) *The calculations developed pursuant to section 19 of this regulation;*

19 (h) *The division approves other drawings, specifications, calculations,*
20 *studies or other documents specifically requested by the division;*

21 (i) *The portions of the new process or explosives manufacturing operation*
22 *reviewed by the division pursuant to sections 14 through 21, inclusive, of this*
23 *regulation have been found to be in conformance with the requirements of the*
24 *conditional use permit issued pursuant to NRS 278.147; and*

25 (j) *The division has completed the public review and comment process and;*

26 (1) *Has elected to issue the permit to construct pursuant to paragraph a of*
27 *subsection 2 of section 23 of this regulation; or*

28

1 (2) *Has required modifications pursuant to paragraph b of subsection 2 of*
2 *section 23 of this regulation and the owner of operator has made the*
3 *modifications to the satisfaction of the division.*

4 2. *Modifications that cause the alteration of any document, drawing or*
5 *specification permitted under subsection 1 of this section shall be subject to the*
6 *applicable provisions of management of change and pre-startup safety review*
7 *pursuant to NAC 459.95423 and 459.95425.*

8 **Sec. 23. 1.** *Upon determining concurrence with paragraphs a through i,*
9 *inclusive, of subsection 1 of section 22, the division must issue a notice of intent*
10 *to approve the permit to construct. The notice must:*

11 (a) *Be sent to the applicant and the local governing body in the area in*
12 *which the process is to be located, and published in a newspaper of general*
13 *circulation for the area in which the site is located;*

14 (b) *Summarize the intended action by the division and note that the*
15 *following information is available for review:*

16 (1) *The registration submitted pursuant to paragraph a of subsection 1 of*
17 *section 14 of this regulation;*

18 (2) *The coordinated emergency response plan submitted pursuant to*
19 *paragraph b of subsection 1 of section 14 of this regulation;*

20 (3) *The site plan submitted pursuant to subsection 1 of section 17 of this*
21 *regulation; and*

22 (4) *A copy of the conditional use permit submitted pursuant to paragraph*
23 *e of subsection 1 of section 14 of this regulation.*

24 (c) *State that the division will accept comments for 30 days after the date that*
25 *the notice is issued; and*

26 (d) *Describe the procedure for obtaining copies of the available documents.*

27 2. *Within 15 days of the closure of the public comment period, the division*
28 *must consider the comments and elect to either:*

- 1 (a) *Issue the permit to construct;*
2 (b) *Require further modifications; or*
3 (c) *Deny the permit.*
4 3. *If the permit is denied, the division must provide an explanation, citing the*
5 *appropriate section of the regulation that supports such a denial.*

6 **Sec. 24.** *During the construction activity permitted pursuant to section 22 of*
7 *this regulation:*

8 1. *The owner or operator:*

9 (a) *Shall maintain on site;*

10 (1) *All documents, drawings and specifications related to the new process*
11 *or explosives manufacturing operation, including the set of documents, drawings*
12 *and specifications approved by the division pursuant to subsection 1 of section*
13 *22 of this regulation;*

14 (2) *All inspection and testing records; and*

15 (3) *All construction procedure and construction personnel qualification*
16 *records; and*

17 (b) *Shall make all information maintained on site pursuant to paragraph a of*
18 *this subsection, available to the division or authorized representative upon*
19 *request.*

20 2. *The owner or operator shall provide the division five days notice of dates*
21 *on which:*

22 (a) *Concrete foundations will be poured;*

23 (b) *Structural steel erection will commence;*

24 (c) *Process piping fabrication will commence;*

25 (d) *Process piping hydrotesting will commence; and*

26 (e) *Any other activities identified by the division or authorized representative*
27 *that will be performed.*

28

1 **Sec. 25. 1.** *Submission of the assessment report pursuant to paragraph c of*
2 *subsection 2 of this section shall be considered the application for a permit to*
3 *commence operation.*

4 **2.** *The division will issue a permit to commence operation to the owner or*
5 *operator of the new process or new explosives manufacturing operation that will*
6 *become subject to the provisions of tier A pursuant to NAC 459.95323 or tier B,*
7 *program level 2 or 3 pursuant to NAC 459.95325 or 459.95327, after:*

8 **(a)** *The permit to construct for the new process or new explosives*
9 *manufacturing operation has been issued pursuant to section 22 of this*
10 *regulation;*

11 **(b)** *Concrete foundations and steel drawings and calculations related to the*
12 *new process that are being permitted by the local building official have received*
13 *the appropriate permits;*

14 **(c)** *An assessment report containing the information required pursuant to*
15 *NAC 459.95452 through 459.95466, inclusive is submitted to the division and all*
16 *P.T.A.H. measures have been resolved. The assessment report shall be submitted*
17 *no less than 60 days prior to commencing the operation of the new process or*
18 *explosives manufacturing operation and prior to bringing tier A substances, tier*
19 *B substances or explosives on site;*

20 **(d)** *The division has determined the requirements of NAC 459.95412 through*
21 *459.95442, inclusive, have been satisfied; and*

22 **(e)** *Any balance due to the division for fees that are assessed pursuant to*
23 *section 26 of this regulation has been paid.*

24 **Sec. 26. 1.** *As defined in this section, the owner or operator of a new process*
25 *or new explosives manufacturing operation shall remit fees to the division for*
26 *permitting activities conducted pursuant to sections 11 and 12 of this regulation.*

27 **2.** *After the division finds the application complete pursuant to section 15 of*
28 *this regulation:*

1 (a) *The owner or operator shall remit \$5,000 to the division. The division*
2 *will subsequently issue invoices for cost incurred in excess of \$5,000, up to a*
3 *cumulative amount of:*

4 (1) *\$40,000 for a new process or explosives manufacturing operation with*
5 *5 or less piping and instrument diagrams, exclusive of drawing legend sheets,*
6 *developed pursuant to subparagraph 2 of paragraph c of subsection 2 of*
7 *NAC 459.95412;*

8 (2) *\$50,000 for a new process or explosives manufacturing operation with*

20 or operator shall submit a report of compliance for any process *or explosives manufacturing*
21 *operation* that is subject to the tier A program.

- 11 9. A certification as set forth in subsection 2 of NAC 459.95466.
