**Re:** Notice of Alleged Air Quality Violation: Nos. 2259, 2260, 2261, 2272 and 2299  
Class II Air Quality Operating Permit AP1611-2306.02; COLA 2205 (FIN A0076)

Dear Mr. Portman:

On February 9, 2011 the Nevada Division of Environmental Protection, Bureau of Air Pollution Control (NDEP) and Road and Highway Builders, LLC (R&HB) held an enforcement conference to discuss R&HB's alleged failure to comply with Class II Air Quality Operating Permit AP16112306.02, COLA 2205. Based on the information presented during the enforcement conference the NDEP determined that issuance of Notice of Alleged Air Quality Violation and Order (NOAV) No.'s 2259, 2260, 2261, 2272 and 2299 is warranted. Failure to comply with Class II Air Quality Operating Permit AP16112306.02, COLA 2205 represents an air quality violation under **NAC 445B.275 Violations: Acts constituting; notice** (see below).

The attached NOAV No.'s 2259, 2260, 2261, 2272 and 2299 allege that R&HB is in violation of **Nevada Administrative Code (NAC) 445B.275 Violations: Acts constituting; notice**. **NAC 445B.275** states, in part, that: "1. Failure to comply with any requirement of NAC 445B.001 to 445B.3791, inclusive, any applicable requirement or any condition of an operating permit constitutes a violation. As required by Nevada Revised Statutes NRS 445B.450, the Director shall issue a written notice of an alleged violation to any owner or operator for any violation, including, but not limited to:

(c) Failure to construct or operate a stationary source in accordance with any condition of an operating permit.


NOAV No.'s 2259, 2260, 2261, 2272 and 2299 constitute major violations under **NAC 445B.281 Violations: Classification; administrative fines**. Failure to comply with a permitted operational limitation constitutes a major violation. Along with related Notice of Air Quality Violation and Order (NOAV) No.'s 2179-2184, issued in November of 2009, NOAV No. 2259, 2260, 2261, 2272 and 2299 represents R&HB's seventh air quality violation within the last 60 months. As was discussed during the enforcement conference, **NOAV No. 2299** will be issued as a warning.



An appeal of NOAV No. **2259, 2260, 2261, 2272** and **2299** may be requested pursuant to **Nevada Revised Statutes (NRS) 445B.360** and SEC administrative rules. A copy of SEC Appeal Form #3 is enclosed. Appeals must be received within 10 days of receipt of this notice, pursuant to **NRS 445B.340**. Appeals are processed through John Walker, the Executive Secretary for the SEC, at 901 South Stewart Street, Suite 4001, Carson City, Nevada, 89701-5249. No person may cause or permit the handling, storing, or transporting of any material in a manner which allows or may allow controllable particulate matter to become airborne. 2. Except as otherwise provided in subsection 4, no person may cause or permit the construction, repair, demolition, or use of unpaved or untreated areas without first putting into effect an ongoing program using the best practical methods to prevent particulate matter from becoming airborne. As used in this subsection, "best practical methods" includes, but is not limited to, paving, chemical stabilization, watering, phased construction and re-vegetation.

**It is alleged that the following act or practice constitutes the violation:**

Failure to control fugitive dust.

**Evidence:**

Road and Highway Builders (R&HB) operates an aggregate processing facility and hot-mix asphalt plant near Lovelock, NV in Pershing County under Class II General Air Quality Operating Permit AP1611-2306, COLA #2205. COLA #2205 was issued on December 18, 2009.

On June 9, 2010, Nevada Division of Environmental Protection, Bureau of Air Pollution Control (NDEP-BAPC) inspectors observed that R&HB was operating during a high wind event and fugitive dust was observed. R&HB failed to control fugitive dust as required by NAC 445B.22037.

Along with related Notice of Air Quality Violation and Order (NOAV) No's. 2179-2184, issued in November of 2009, NOAV No. 2259 represents R&HB's seventh air quality violation within the last 60 months.

R&HB complied with the official's verbal request to shutdown the hot mix asphalt plant.

Failure to operate required emission controls constitutes a major violation. Along with related Notice of Air Quality Violation and Order (NOAV) No's. 2179-2184, issued in November of 2009, NOAV No. 2260 represents R&HB's seventh air quality violation within the last 60 months.

R&HB complied with the official's verbal request to shutdown the hot mix asphalt plant.

Failure to comply with a permitted emission limit constitutes a major violation. Along with related Notice of Air Quality Violation and Order (NOAV) No's. 2179-2184, issued in November of 2009, NOAV No. 2261 represents R&HB's seventh air quality violation within the last 60 months.

The NDEP-BAPC met with R&HB again on February 9, 2011 to discuss the recent non-compliance discovery. R&HB explained that although the NDOT contract and the NDEP air quality permit were issued to R&HB; Rees's Construction was sub-contracted for the crushing and screening work. It was explained to the NDEP-BAPC that Rees's was given a copy of the permit and was aware of the operating limitations set by the permit. RH&B was told that the owner or operator of a permit is responsible for permit compliance.

Failure to comply with a permitted operational limitation constitutes a major violation. Along with related Notice of Air Quality Violation and Order (NOAV) No's. 2179-2184, issued in November of 2009, NOAV No. 2272 represents R&HB's seventh air quality violation within the last 60 months.

It was explained to the NDEP-BAPC that Rees's was given a copy of the permit and was aware of the operating limitations set by the permit. RH&B was told that the owner or operator of a permit is responsible for permit compliance.

Failure to comply with a permitted operational limitation constitutes a major violation. Along with related Notice of Air Quality Violation and Order (NOAV) No's. 2179-2184, issued in November of 2009, NOAV No. 2299 represents R&HB's seventh air quality violation within the last 60 months.
