Hearing Agenda - SEC Appeal Hearing

Rejection of the document titled, *Addendum to Offsite Corrective Action Plan For the Commingled MTBE Plume*, submitted by Avis Budget Car Rental, LLC., Facility ID 8-000217.

A three-member panel of the State Environmental Commission (SEC) has scheduled an appeal hearing regarding the Nevada Division of Environmental Protection's (NDEP) rejection of the above referenced document. The hearing will be held on March 14, 2019, beginning at 9:30 a.m. in the Tahoe Conference Room (second floor) of the Richard H. Bryan Building, 901 South Stewart Street, Carson City, Nevada. The hearing will be videoconferenced to Room 1400 of the Grant Sawyer State Office Building, 555 East Washington Avenue, Las Vegas, Nevada.

The following items may be taken out of order and/or items may be combined for consideration. Items may also be removed from the agenda, or the SEC may delay discussion relating to an item on the agenda at any time. Prior to the commencement and conclusion of a contested case or a quasi-judicial proceeding that may affect the due process rights of an individual, the SEC may refuse to consider public comment. See *Nevada Revised Statutes* (NRS) 233B.126.
