ORDER REGARDING  
BRIEFING SCHEDULE

On March 7, 2022, Great Basin Resource Watch, filed an appeal of Permit NEV2020104 issued on February 25, 2022, by the Nevada Division of Environmental Protection to operator Lithium Nevada Corp., for a Groundwater Pollution Control Discharge Permit.

Pursuant to NAC 445B.8925, it is hereby ORDERED that Great Basin Resource Watch shall file their opening brief with the State Environmental Commission ("SEC") on or before April 22, 2022. The brief should contain a detailed statement of the issue(s) to be raised during the hearing. It is also ORDERED that Lithium Nevada Corp. and the Nevada Division of Environmental Protection shall each file a responsive brief on or before May 20, 2022. It is further ORDERED that Great Basin Resource Watch may file a reply brief on or before June 10, 2022. In addition, it is further ORDERED that on or before June 14, 2022, each party shall exchange with each other party, notice of the identity of each person who will offer direct oral testimony at the hearing and each party shall exchange copies of each exhibit the party intends to offer as evidence at the hearing. The parties are encouraged to submit exhibits jointly where possible to avoid duplicate exhibits. Lastly, the appeal hearing in this matter is scheduled for June 28 and 29, 2022.
