Water Pollution Control Permit NEV2008106

A three-member panel of the State Environmental Commission (SEC) has scheduled an appeal hearing regarding the above referenced permit. The appeal hearing will be held on Wednesday, September 4, 2019, beginning at 9:00 a.m. in the Tahoe Conference Room (second floor) of the Richard H. Bryan Building, 901 South Stewart Street, Carson City, Nevada. If necessary, the hearing will continue the following day, September 5, 2019, beginning at the same time and in the same location.

The following items may be taken out of order and/or items may be combined for consideration. Items may also be removed from the agenda or the SEC may delay discussion relating to an item on the agenda at any time. Prior to the commencement and conclusion of a contested case or a quasi-judicial proceeding that may affect the due process rights of an individual, the SEC may refuse to consider public comment.
