Subject: Notice of Continued Prehearing Conference: Nevada Division of Environmental Protection (NDEP) Permit No. NEV2008106

A three-member panel of the State Environmental Commission (SEC) has scheduled a continuation of the prehearing conference held on May 1, 2019 regarding the above referenced permit. The continued prehearing conference will be held on June 20, 2019, beginning at 9:30 a.m. in the Tahoe Conference Room (second floor) of the Richard H. Bryan Building, 901 South Stewart Street, Carson City, Nevada 89701. The continued prehearing conference date was selected during the May 1, 2019 prehearing conference.

The SEC has jurisdiction to hear this appeal pursuant to NRS 445A.425 and NRS 445A.605. The statutes and regulations allegedly violated, as cited in the request for an appeal form submitted by GBRW, are: NRS 445A.305, NRS 445A.335, NRS 445A.405, NRS 445A.415, NRS 445A.425, NRS 445A.465, NAC 445A.2268, NAC 445A.121, NAC 445A.424-425, NAC 445A.429, NAC 445A.465, NAC 445A.446, NAC 445A.429-431, NAC 4456A.424 and NAC 445A.429.

About the Continued Prehearing Conference: During the prehearing conference held on May 1, 2019, The SEC deliberated on NDEP's motion to

dismiss GBRW's request for an appeal hearing. It was determined that the prehearing conference would be continued. NDEP would be permitted to amend its motion to dismiss, followed by the submittal of a brief by GBRW and a reply brief by NDEP.

The issues associated with the continued prehearing conference will be further clarified within the briefs required by the SEC in an order issued on May 3, 2019.
