7 On November 1, 2018, both parties to this appeal hearing mutually agreed to reset the appeal
8 hearing date and the briefing schedule.

10 opening brief with the State Environmental Commission ("SEC") on or before Monday, November 26,
11 2018. The brief should contain a detailed statement of the issue(s) to be raised during the hearing. It is
12 further ORDERED that the Nevada Division of Environmental Protection shall file a responsive brief
13 on or before Monday, December 10, 2018. It is further ORDERED that Nathaniel Seltenreich may file a
14 reply brief on or before Friday, December 14, 2018. It is further ORDERED that each party shall
15 exchange with each other party, notice of the identity of each person who will offer direct oral
16 testimony at the hearing and each party shall exchange copies of all exhibits the party intends to offer as
17 evidence at the hearing not later than Friday, December 14, 2018. The parties are encouraged to submit
18 exhibits jointly where possible to avoid duplicate exhibits. Lastly, the appeal hearing in this matter is
19 scheduled for December 19, 2018 at 9:30 a.m. at a location in Las Vegas that will be identified in the
20 forthcoming notice for this hearing. All submittals to the SEC shall be provided electronically to
21 Valerie King at vking@ndep.nv.gov.


