NEVADA DIVISION OF ENVIRONMENTAL PROTECTION'S RENEWED MOTION TO DISMISS APPEAL

Nevada Division of Environmental Protection, Bureau of Mining Regulation and Reclamation ("NDEP"), by and through counsel, Catherine Cortez Masto, Attorney General for the State of Nevada, Cassandra Joseph, Senior Deputy Attorney General, hereby renews its Motion to Dismiss the appeal of the renewal of the Water Pollution Control Permit No. NEV0070005 (the "Permit"), to Silver Peak Lithium Project (Chemetall Foote) (the "Permittee"). NDEP filed its Motion to Dismiss on September 20, 2012. The State Environmental Commission has not yet ruled on that motion.

In addition, NDEP hereby moves to dismiss this appeal on the additional grounds that Appellant has failed to prosecute the appeal. Appellant Silver Peak Ad Hoc Advisory Committee filed its appeal more than nine months ago on August 18, 2012. On March 22, 2013, the SEC entered an order setting a hearing date and a briefing schedule. Upon request by Appellant for an extension of time, on May 1, 2013, the SEC amended the briefing schedule and ordered Appellant to file a brief with the SEC by May 17, 2013. Appellant failed to file a brief and provided no explanation for not filing a brief.

For the reasons stated in its Motion to Dismiss filed on September 20, 2013, and because Appellant has not complied with the SEC's May 1, 2013 Order regarding briefing,
