ORDER REGARDING
BRIEFING SCHEDULE

On September 8 and 9, 2026, Cheryl and Raymond Varkalis, Ruth Matthew, and John O'Brien, and A. J. Brown (collectively, the Appellants), filed an appeal of Permit SW1900REV00 issued on August 26, 2026, by the Nevada Division of Environmental Protection to Ryan Oganessian, for a Medical Waste Treatment Facility Permit.

Pursuant to NAC 445B.8925, it is hereby ORDERED that the Appellants shall file their opening brief with the State Environmental Commission ("SEC") on or before September 16, 2026. Each brief should contain a detailed statement of the issue(s) to be raised during the hearing. It is also ORDERED that the Nevada Division of Environmental Protection shall file a responsive brief on or before September 22, 2026. It is further ORDERED that the Appellants may file a reply brief on or before September 23, 2026. In addition, it is further ORDERED that on or before September 23, 2026, each party shall exchange with each other party, notice of the identity of each person who will offer direct oral testimony at the hearing and each party shall exchange copies of each exhibit the party intends to offer as evidence at the hearing. The parties are encouraged to submit exhibits jointly where possible to avoid duplicate exhibits. Lastly, the appeal hearing in this matter is scheduled for September 28, 2026.
