**Permanent Regulation R120-19:** The NDEP is proposing to update NAC 445B.221, "Adoption by reference and applicability of certain provisions of federal law and regulations." The NDEP is proposing to adopt into State regulation certain provisions of the federal *New Source Performance Standards, National Emission Standards for Hazardous Air Pollutants*, and other federal rules applicable in Nevada that have been adopted by the U.S. Environmental Protection Agency (USEPA) and published in the Federal Register since October 1, 2017.
