



Notice of Workshop to Solicit Comments on Proposed Amendments to Nevada Administrative Code Chapter 445B – Air Pollution

The Nevada Division of Environmental Protection (NDEP) is proposing a regulation that will provide an exemption, under certain circumstances, from the requirement that motor vehicles registered in Nevada that were originally equipped with devices to control pollution must have those devices correctly installed and in good operating condition. Temporary Regulation T2017-02: The NDEP is proposing to provide an exemption, under certain circumstances, from the requirement that motor vehicles registered in Nevada that were originally equipped with devices to control pollution must have those devices correctly installed and in good operating condition. The amendment will update the NAC to provide an exemption that applies to those motor vehicles subject to a settlement agreement entered into by the State of Nevada, an Agency of the State of Nevada, or to which the State of Nevada is a beneficiary, that is intended to mitigate the effects of any device for the control of pollution which is not correctly installed or in operating condition in accordance with the specifications of the vehicle manufacturer and any applicable state or federal statute or regulation. The amendment does not relieve the owner of the requirement to obtain evidence of compliance with the Nevada emission inspection program prior to registration of the vehicle in those counties where the program is being implemented, i.e., the vehicle must pass the annual emission inspection and will not be exempted for other mechanical defects or disrepair that results in a test failure.
