## Air Penalty Assessments

#### 4) Kennametal, Inc. - NOAV No. 2905 (For Possible Action)

Alleged violation of NAC 445B.001 to 445B.3689, inclusive - failure to construct or operate a stationary source in accordance with any condition of an operating permit (Air Quality Operating Permit AP3399-0120; FIN A0531).

**Recommendation:** Approve NDEP-recommended penalty for Kennametal, Inc. in the amount of \$5,040 for NOAV No. 2905 or take other action as appropriate.

## 5) Robertson's Ready Mix - NOAV No. 2895 (For Possible Action)

Alleged violation of NAC 445B.001 to 445B.3689, inclusive - failure to construct or operate a stationary source in accordance with any condition of an operating permit (Air Quality Operating Permit AP3273-3982; FIN A0121).

**Recommendation:** Approve NDEP-recommended penalty for Robertson's Ready Mix in the amount of \$7,200 for NOAV No. 2895 or take other action as appropriate.

#### 6) Wulfenstein Construction Company, Inc. - NOAV No. 2888 (For Possible Action)

Alleged violation of NAC 445B.001 to 445B.3689, inclusive - failure to construct or operate a stationary source in accordance with any condition of an operating permit (Air Quality Operating Permit AP1611-0519; FIN A0475).

**Recommendation:** Approve NDEP-recommended penalty for Wulfenstein Construction Company, Inc. in the amount of \$9,000 for NOAV No. 2888 or take other action as appropriate.

# **Regulatory Petitions**

#### 7) Permanent Regulatory Petition R103-22 (For Possible Action)

R103-22 proposes an amendment to NAC 459, increasing the fees for the Nevada Division of Environmental Protection's Chemical Accident Prevention Program (CAPP). This increase in fees will ensure that CAPP can continue to perform its statutory requirements including permitting, inspection, and compliance of facilities with appropriate staffing levels and staff development.

## 8) Permanent Regulatory Petition R104-22 (For Possible Action)

R104-22 proposes revisions to existing regulation NAC 445A in order to reduce/minimize special exception requests during project review by aligning regulations with current best engineering practices.
