**Permanent Regulation R103-22:** The NDEP is proposing to amend the CAPP fee schedule and other regulations under NAC 459. Fee increases will ensure CAPP can continue to perform its statutory requirements including permitting, annual inspections of facilities, and appropriate staffing and staff development. The fees were last increased almost 20 years ago. Without the fee increase, revenue will not balance with program expense projections.
