In this regulation the Nevada Division of Environmental Protection proposed to amend four sections in the permitting provisions of NAC 445B. The amendments are in response to U.S. EPA comments on the approvability of the agency's air pollution control permitting provisions into the applicable State Implementation Plan. The amendments align state regulations with the federal Clean Air Act and U.S. EPA rule requirements.
