## Notice of Public Workshops Proposed Changes to Nevada Water Quality Standards - South Fork Reservoir and Upper Humboldt River Basin Tributaries

**April 30, 2014**

The Nevada Division of Environmental Protection, Bureau of Water Quality Planning (NDEP-BWQP) is proposing to revise the water quality standards for South Fork Reservoir and selected tributaries to the Humboldt River in the Upper Humboldt River Basin. Proposed revisions include: 1) South Fork Reservoir - creation of a separate reach for South Fork Reservoir, modification of nutrient and dissolved oxygen criteria, and addition of Secchi depth criteria; and 2) South Fork Reservoir and Humboldt Basin tributaries - addition of nitrate, nitrite, total suspended solids, turbidity, color, chloride, sulfate and alkalinity criteria.
