Permanent Regulation P2019-04: The NDEP is proposing a comprehensive amendment to the fee structure in NAC 445B.327 for the Bureaus of Air Pollution Control and Air Quality Planning. The amendment seeks to update the Air Program's approach to how fees are assessed to align the revenue to the increasing costs associated with the implementation of the Air Program, and to redistribute fees across the regulated industry to reflect workload and resources required to implement the Air Program.
