Summary:

- Brendon Grant (Brendon) and Andrea Seifert (Andrea) started the Public Workshop (Workshop) by introducing themselves and then asked the participants to state their name and the organization they represent. Brendon then reviewed the various ways the public could participate during the Workshop, which included telephone, virtual, and inperson. The presenters provided background information on the Executive Order issued by Governor Lombardo and the reason Bureau of Safe Drinking Water (BSDW) proposed to revise the selected regulations. Brendon explained how regulations are revised/created and the role the State Environmental Commission has in the process.
- Andrea explained the revisions to NAC 445A.454 and provided an example of how to calculate the running annual average as outlined in 40 CFR 141.23(i).

- Brendon spoke about the general clean up to NAC 445A.495 section of surface water regulations.
- Brendon presented BSDW's determination to waive the requirement of a Preliminary Engineering Report (PER) for groundwater treatment on a privately owned non-community public water system, inclusion of the definition of a water project in the groundwater treatment section, and clarification of the requirement to submit a pilot study or certification document on the selected treatment technology for secondary contaminants.
- Brendon spoke about the inclusion of the American Society of Sanitary Engineers (ASSE) as an organization who may certify a person to test backflow assemblies.
- Brendon explained the reasons BSDW decided to repeal NAC 445A.6681 and how treatment plant safety and efficiency were going to be included in other regulations (NAC 445A.66785 and NAC 445A.66805).
- Brendon spoke about the inclusion of ANSI/NSF 61 certified HDPE storage tanks in NAC 445A.66805 and the updated reference to the AWWA M25 Manual.
- Brendon presented on the inclusion of a cap to the water treatment facility review fees in NAC 445A.6664.
- Mr. Mitch Dion from Kingsbury GID voiced his support for the revisions and was glad to see BSDW reaching out to public water systems regarding regulation revisions.
- Nik Taranik with the Nevada National Security Site asked a clarifying question regarding the revisions to NAC 445A.454. The question was answered by Andrea.
