NOTICE OF PUBLIC WORKSHOP Proposed Regulation Petitions LCB File No. R112-22 Bureau of Water Pollution Control September 28, 2022

The Nevada Division of Environmental Protection (NDEP), Bureau of Water Pollution Control (BWPC) is proposing to adopt regulation petition LCB File No. R112-22 amending Chapter 445A of the Nevada Administrative Code (NAC) 445A.232, 445A.268, 445A.872, 445A.963 – Fees. R112-22 Fees: The proposed regulations include increases to fees required to obtain permits to authorize discharges to the environment (surface or groundwater). The permits are required for all dischargers including private individuals as well as private industry and public entities. The fee increases are necessary to ensure adequate BWPC staffing for timely review and approval of permit applications, to ensure adequate technical services are available for permittees, to ensure timely and necessary compliance and enforcement actions are initiated and to provide the necessary administrative assistance to the public. A review of the projected revenue and expenditures generated from the existing fee schedules reveals that sufficient to adequately respond to increasing permit applications, technical review requests and compliance issues throughout the state. These shortfalls in permitting and compliance have been documented in audits conducted by the United States Environmental Protection Agency.

The workshop will be held virtually from the Bryan Building at 901 South Stewart Street, Carson City, NV in the Great Basin Room, located on the 4th Floor and will be organized for participation in-person or virtually using the link provided for the virtual webinar below. The Great Basin Conference Room has a limited capacity, but the Division will attempt to accommodate all persons who wish to participate in-person.
