CALL TO ORDER

Mr. Tucker called the meeting to order and explained the purpose of the Public Workshop. Staff and attendees introduced themselves. Mr. Tucker explained that the names of attendees would be collected for the record and that the meeting was being recorded. Mr. Tucker reviewed the workshop agenda. There were no questions or changes to the agenda. Mrs. Bobo explained that virtual attendees would be muted by the moderator and how they could signal to the moderator that they had a question or comment so they could be unmuted. Mrs. Bobo explained that a copy of the proposed regulations, and State Environmental Commission Forms 1 and 4 could be found on NDEP's website.

Mr. Tucker explained how the regulation adoption process works. The regulation adoption timeline was explained, specifying that after the workshop there would a be 30-day public comment period prior to the State Environmental Commission (SEC) hearing set for December 5th, 2023. Additional information about the hearing can be found on the SEC website. If the regulations are adopted by the SEC, they are submitted to the Legislative Commission. If the Legislative Commission approves the regulations, they are filed with the Secretary of State and become effective. Mr. Tucker paused and asked if there were any questions about the regulation adoption process.

Mr. Tucker moved on to present the petitions.

P2023-01 SUMMARY

Mr. Tucker presented P2023-01, proposed amendments to NAC 445B.22097. Mr. Tucker explained that the amendments add language that pertain to notifications made by the agency to the public about events where the ambient air quality standards may be exceeded, such as when smoke from wildfires adversely affects air quality, and inform the public about the health hazards associated with these events. NDEP has historically provided notifications of these events and the associated health hazards to the public and will continue to do so. The adoption of these regulations serves to satisfy Federal Cean Air Act requirements for State Implementation Plans. If adopted, this regulation will be submitted to the U.S Environmental Protection Agency for incorporation into the Nevada State Implementation Plan (SIP).

Mr. Tucker paused and asked if there were any questions. He reminded the virtual attendees that they could use the "raise hand" function or send a message in the chat window to ask a question Mr. Tucker informed the attendees calling in by phone that they would be unmuted if they had any questions.

P2023-02 SUMMARY

Mr. Tucker presented P2023-02, to propose the streamlining requirements of the Chemical

Accident Prevention Program by amending the Regulation of Highly Hazardous Substances and Explosives under NAC Chapter 459, specifically NAC 459.953451. Executive order 2023-003, issued by Governor Lombardo on January 12, 2023, directed state agencies to review regulations to identify regulations that can be streamlined. As part of that review, it was identified that the two additional copies of permit applications required pursuant to NAC 459.953451, were no longer necessary. The proposed amendments remove the requirement to provide two additional copies of the application and will help with efficiency in administering the Chemical Accident Prevention Program.

Mr. Tucker paused and asked if there were any questions. He reminded the virtual attendees that they could use the "raise hand" function or send a message in the chat window to ask a question Mr. Tucker informed the attendees calling in by phone that they would be unmuted if they had any questions.

P2023-03 SUMMARY

Mr. Tucker presented P2023-03. In accordance with the directives Executive Order 2023-003, NDEP is proposing to clarify and reduce regulatory burden by repealing the entirety of the regulations for the administration and enforcement of the Alternative Fuels Program codified in NAC 486A.010 to NAC 486A.250, inclusive. These regulations are no longer necessary, because on May 29, 2019, Senate Bill 42 repealed Nevada Revised Statute (NRS) 486A.010 to 486A.200. The repealed statues provided the statutory authority to administer the Alternative Fuels Program. Repealing these regulations would resolve the inconsistency between regulatory requirements and statutory authority and prevent confusion.

He reminded the virtual attendees that they could use the "raise hand" function or send a message in the chat window to ask a question Mr. Tucker informed the attendees calling in by phone that they would be unmuted if they had any questions.

COMMENTS AND QUESTIONS

Ryan Pessah: Can you please restate the reason for repealing 486A?

Andrew Tucker: The reason for repealing 486A is because the underlying statutory authority that was given to NDEP to administer and enforce the program was repealed in 2019 under Senate Bill 42. Without that statutory authority NDEP would not be able to implement and enforce the requirements of the program.
